HOW MUCH IS IN THE GRANT FUND?

For 2024-2025 the grant pool is \$75,000.00. Max awarded grant per recipient is \$25,000.00.

WHAT FACTORS WILL BE CONSIDERED FOR AWARDING GRANTS?

When judging the grant applications, the committee will consider:

- 1) the economic impact
- 2) strategic importance
- 3) quality of the project
- 4) potential job creation or job retention
- 5) needs of the community
- 6) matching funds for the project
- likelihood of the success of the project.

WHAT ARE THE TIME FRAMES FOR USING THE GRANT PROCEEDS?

Capital Matrix anticipates that approved projects will be completed within one year.

HOW DO YOU APPLY FOR A GRANT?

The application process is simple and straightforward. Complete the application form on

the back describing the proposed project with supporting documentation including bids or professional cost estimates if an outside contractor will be used to complete the project.

WHAT IS THE DEADLINE FOR APPLYING?

Monday, March 31, 2025

WHEN WILL THE GRANTS BE AWARDED?

Grant recipients will be announced in May of 2025. Funds will be distributed on a reimbursement basis when the project has been completed.
